



Special conditions for web hosting

Article 1: Purpose

The purpose of these special conditions is to define the technical and financial conditions under which AdKyNet undertakes to ensure the proper functioning of the Customer's shared web hosting (hereinafter the "Service").

The Customer expressly acknowledges that AdKyNet does not participate in the design, development, production and implementation of the Customer's Internet site and its management and administration tools.

Article 2: AdKyNet's obligations

AdKyNet undertakes to intervene quickly in case of problem. AdKyNet undertakes to notify the Customer in case of maintenance on the infrastructure via the website <https://status.adkynet.com>. AdKyNet undertakes to maintain the "host" servers in good working order and to keep them updated 24 hours a day, 7 days a week.

Article 3 : Support

AdKyNet provides the Customer with technical assistance under the conditions set out in the general terms of sale and general terms of use.

Article 4 : Order

The request to open or renew a shared web hosting solution (Windows, Linux, cPanel, Plesk) with AdKyNet is materialized by the issuance of a purchase order duly completed by the Customer and sent to AdKyNet. The dispatch of this order form implies acceptance without reservation by the Customer. AdKyNet shall only be contractually bound to the Customer after full payment of the required amounts. Upon receipt of the order form, AdKyNet shall send the Customer an account opening confirmation e-mail, providing the Customer with the codes enabling him to access the space reserved for his Internet site on the AdKyNet Service. The date on which the Customer's site hosting codes are sent determines the initial date on which billing takes effect.

Article 5: Responsibility of AdKyNet

AdKyNet reserves the right to interrupt the service, in particular if the server constitutes a danger to the maintenance of the security of AdKyNet's hosting platform, whether as a result of hacking or unauthorized site updates resulting in the detection of a security flaw in the system. AdKyNet undertakes to restore the connection at the request of the customer.

Article 6: Responsibility and obligations of the customer

The customer undertakes not to host racist, pornographic or illegal sites and those with hyperlinks to this type of sites are prohibited on the infrastructure of AdKyNet, any non-compliance with this instruction, the customer will be temporarily suspended services.

In the same way, it is forbidden to host any site on pages having to do with any proselytism relating to sectarian movements such as denounced on the parliamentary report "Sects in France", or considered as representing a sectarian risk for the services of the State, or recognized as such by a decision of Justice having authority of the judged thing. He also undertakes not to make any redirection to this type of site.

The customer is responsible for respecting the volume of traffic and storage space made available to the customer to which he has subscribed.

The customer is informed that he is subject to copyright and intellectual property rights for all files on the servers.

The customer is prohibited from using the services for streaming purposes. The Customer undertakes to put in place the necessary means of backup for the continuity of his activity.

The Customer, who is solely responsible for the content of the Service, undertakes to defend AdKyNet at its own expense in the event that the latter should be the subject of an action for damages relating to the data, information, messages, etc., that it broadcasts, and to pay the compensation due for any damage suffered, provided that the Customer is free to settle and conduct the proceedings.
